Managed labor collaborations and community coalitions as staff liaison for 130+ affiliated unions, representing more than 100,000 working families in Alameda County (fourteen cities including Oakland, Berkeley, Emeryville, and unincorporated areas). Activities included hundreds of actions, picket lines, and rallies, involving thousands of union members and community allies in support of contract campaigns.
